Introduction

Annual report on the provision of State aid to undertakings prepared by the Antimonopoly Committee of Ukraine (hereinafter – the Committee), which is the authorized body for issues of State aid¹, according to part seven of article 16 of the law of Ukraine "On State aid to undertakings", according to which the authorized body annually, before 1 September of the following year, prepares an annual report on the granting of State aid in Ukraine for the previous financial year and submits it to the Cabinet of Ministers of Ukraine.

The law of Ukraine "On State aid to undertakings" (hereinafter – the Law), which entered into force 02.08.2017 was adopted by the Verkhovna Rada of Ukraine on 01.07.2014 for the international obligations of Ukraine, which arose, in particular, by the signing of the Association Agreement between Ukraine, on the one hand, and the European Union, the European Atomic Energy Community and their Member States (hereinafter – Association Agreement), on the other hand, and of the Treaty establishing the Energy Community².

One of Ukraine's obligations under Article 263 of the Association Agreement is to ensure transparency in the field of State aid. For this purpose, each party to the Association Agreement annually sends a notification to the other party on the total amount, types and industry distribution of State aid, which may affect trade between the parties.

To fulfil this obligation, the Committee annually reflects relevant information in its reports on the provision of State aid to undertakings. Reports for 2017, 2018 and 2019 were sent to the European Commission through the contact point of the Ukrainian side for the exchange of information.

This report provides information on State aid to undertakings in 2020, based solely on information that was provided to the Committee by State aid providers and received during the consideration of communications and cases on State aid. Thus data is presented excluding the temporarily occupied territory of the Autonomous Republic of Crimea, Sevastopol and temporarily occupied part of the territories in the Donetsk and Luhansk regions.

1. The system of monitoring and control of State aid to undertakings in Ukraine

The law establishes the legal basis for monitoring State aid to undertakings, monitoring the compatibility of such aid for competition, establishes the obligation of State aid grantors to submit reports on new and existing State aid, and defines a mechanism for returning State aid that is incompatible for competition. The law is aimed at ensuring the protection and development of competition, increasing the transparency of the State aid system and compliance with Ukraine's international obligations in the field of State aid.

According to article 3 of the Law, the Law applies to all support entities grantors of State aid through state resources or local resources for the production of goods or execution of certain types of economic activity except for the cases stipulated by part two of article 3 of the Law.

The Law does not apply to the following aid³:

- 1) agricultural production and fishery, production of weapons and military equipment for the Armed Forces of Ukraine, other formed under the laws of Ukraine of military formations and law enforcement agencies of special purpose, state special transport service, State Service of Special Communications and Information Protection of Ukraine;
 - 2) economic activities related to:

investment in infrastructure using public procurement procedures;

provision of services of general economic interest, in terms of compensation for reasonable costs for the provision of such services. The list of services of general economic interest is established by the Cabinet of Ministers of Ukraine⁴;

- 3) projects implemented by the Ukrainian Cultural Fund following the procedure established by the Law of Ukraine "On the Ukrainian Cultural Fund"⁵.
- 4) projects implemented by the Ukrainian book Institute by the procedure established by the Law of Ukraine "On state support for book publishing in Ukraine"⁶;
- 5) projects implemented by the Ukrainian Youth Foundation under the procedure established By The Law Of Ukraine "On the basic principles of youth policy"⁷.

To ensure the effective implementation of the powers assigned to the Committee as an Authorized body, the Committee has a Department for monitoring and controlling State aid (hereinafter referred to as the Department). The Department's staffing level at the end of 2020 was 30 people. The department worked with the following units:

four departments with a distributed industry specialization, which, exercising the powers of the Committee following the requirements of the law, in particular, monitor and control State support to undertakings and assess the compatibility of such support for competition, as well as develop regulatory legal acts on state support issues;

analytical sector, which performs analytical and statistical generalization of the results of the Department's work and ensures the functioning of the database of the Register and the Portal of State aid, their administration.

1.1. The concept of State aid to undertakings

According to the definition given in paragraph 1 of article 1 of the Law, State aid to undertakings (hereinafter, State aid) – support in any form of undertakings through state resources or local resources, distorts or threatens with distortion of economic competition by creating advantages for production of certain goods or the implementation of certain types of economic activity.

State aid to undertakings is support in any form of undertakings at the expense of the state or local resources, which distorts or threatens to distort economic competition, creating advantages for the production of certain types of goods or the implementation of certain types of economic activities⁸.

Grantors⁹ of such State aid are represented by authorities, local self-government bodies, administrative and economic management and control bodies, as well as legal entities acting on their behalf, authorized to dispose of state or local resources and initiate and/or provide State aid to the recipient¹⁰.

State support is State aid if the following conditions are met simultaneously:

- support is provided to the undertaking;
- financing of state support is carried out at the expense of state or local resources;
- support creates advantages for the production of certain types of goods or the implementation of certain types of economic activities;
 - support distorts or threatens to distort economic competition.




Figure 1. Scheme for determining State aid support measures

Therefore, a support measure is considered State aid only if the 4 abovementioned cumulative criteria provided for in the definition of State aid are met (see figure 1).

When forming the annual budget of Ukraine, State aid grantors must comply with the requirements of part four of article 35 of the Budget code of Ukraine. In accordance with this part, if the budget request provides for the granting of State aid to undertakings at the expense of the state budget in any form, the main managers of budgetary funds added to the budget request a copy of the decision of the Authorized body on State aids, adopted on the results of reviewing notifications of new State aid, or cases of State aid according to the Law, or written report about their release from the obligation of notification of new State aid regarding the provisions of this Law and normative legal acts, which established the appropriate conditions for dismissal.

1.2. Activities of the Committee as an Authorized body for State aid

The Committee exercises the powers to control the compatibility of State aid for competition, in particular, by making decisions defined in part six of Article 10 and part seven of Article 11 of the Law, based on the results of consideration of notifications of new State aid or cases on State aid.

As defined in part five of Article 9 of the Law, notifications of new State aid are submitted by State aid grantors to the authorized body in accordance with the procedure determined by it, taking into account the terms of consideration of the notification and case on State aid defined by this Law.

The deadline for submitting notifications on new State aid by grantors is determined in the procedure for submitting and processing notifications of new State aid and making changes to the terms of current State aid (hereinafter referred to as Procedure 2-pπ).

In accordance with Procedure 2-p π , notification of new State aid is submitted to the Committee at least 105 days before the planned date of entry into force of the relevant regulatory legal act or decision of the grantor, which allows undertakings to receive new State aid.

Part five of Article 10 of the law regulates that consideration of such a notification is carried out by the Committee's bodies within two months from the date of its beginning and ends with the adoption of a decision of the Committee determined by Part Six of Article 10 of the Law.




Figure 2. Scheme for reviewing a notification on State aid

The scheme for reviewing a notice of new State aid and making changes to the terms of current State aid is shown in Fig. 2.

If there are reasonable grounds for concluding that State aid is incompatible with the competition or that an in-depth analysis of the compatibility of State aid for the competition is carried out on the grounds specified in part one of Article 11 of the Law, the Committee begins to consider the case on State aid following the procedure determined by it.

New State aid provided without notifying the authorized body or in the period after notification, but before the authorized body makes a decision on the compatibility of State aid for competition, or provided contrary to the decision of the authorized body declaring new State aid incompatible with competition, except for categories of State aid, the grantors of which according to this law are exempt from the obligation to notify about new State aid, is illegal State aid following Paragraph 8 of part one of Article 1 of the Law.

The consequence of the Committee's decision to recognize new State aid as incompatible for competition is its termination and return to the relevant budget in full.

The procedure for returning illegal State aid that is incompatible for competition is determined by Article 14 of the Law and resolution of the Cabinet of Ministers of Ukraine No. 468 of 04.07.2017.

At the same time, the legislation establishes that State aid grantors to undertakings, analyzing certain measures of state support for the presence of signs of State aid, taking on their responsibility, have the right not to submit a notification to the Committee, considering that such measures of state support are not State aid, or if State aid is provided in the amount of less than the equivalent of 200 thousand euros for three years, notification of the provision of which is not necessary.




Figure 3. Cases provided for by law in respect of which notifications are not submitted to the Committee




Figure 4. Number of decisions of the Committee in the field of State aid for 2019-2020 (by month)

During 2020, the Committee made **216** substantive decisions in the field of State aid (see figure 4). For comparison, in 2019, **324** decisions were made. The decrease in the number of decisions occurred, in particular, due to a decrease in the number of notifications on new State aid, according to the results of consideration of which state support to undertakings was recognized as non – State aid in accordance with the Law (such decisions in 2020 - 157, in 2019-269).

In 77 decisions adopted in 2020, the Committee defined obligations for State aid grantors to eliminate non-compliance with the Law, of which 15 decisions have obligations to return illegal State aid recognized as incompatible for competition.




Figure 5. Quantitative indicators of the Committee's decisions in the field of State aid for 2019, by type of aid

Quantitative indicators of the Committee's decisions in the field of State aid for 2020 by type of aid are shown in figure 5.

According to the information shown in Table 1, out of the total number of decisions taken by the Committee in 2020, the share of decisions related to the provision of State aid by local self-government bodies is 77%. In 2019, the share of such decisions was 84%.

Quantitative indicators of the Committee's decisions in the field of State aid

for 2020 by form of ownership are shown in figure 6.

In 2020, the overwhelming number of decisions of the Antimonopoly Committee of Ukraine related to support for municipal enterprises -81% of the total number of decisions on State aid, continuing the trend of 2019. In 2019, the share of such decisions was about 84%.

Quantitative indicators of the Committee's decisions in the field of State aid for 2020 by funding sources are shown in figure 7.

The largest number of decisions was made regarding activities in the field of administrative and support services, including the section of the CEA "Maintenance of houses and territories".

The trend in the number of decisions by region in 2020 coincides with the trend in 2019. So, for example, the number of decisions on providing State aid to undertakings in Kyiv remains the largest (58 decisions were made in 2020, 99 decisions in 2019) and accounts for 27% of the total number of decisions taken by the Committee in 2020. The top five regions in terms of the number of decisions made in 2020, similar to the previous year, included the following: Kyiv, Zaporizhia, Dnipropetrovsk, Kharkiv and Donetsk regions.




Figure 8. Number of decisions taken by the Committee by region in 2020

Quantitative indicators of the Committee's decisions in the field of State aid for 2020 by region are shown in figure 8.

The Committee's decisions related to support and State aid totalled **UAH 28,251.36** million (excluding guarantees), including:

- the Committee's decision on the compatibility of State aid for competition concerned the amount of UAH 5,381.55 million;
- the Committee's decision to recognize State aid as incompatible for competition concerned the amount of UAH 238,1 million;
- the decision of the Committee to recognize support for undertakings as not as
 State aid concerned the amount of
- UAH 20,831.59 million;
- state support specified in decisions on the implementation of the functions of the customer, for which the corresponding amounts of compatible/incompatible State aid for the competition cannot be established at the time of making such decisions, UAH 1,800.12 million.

During 2020, 16 decisions were made regarding the provision of State aid in the form of a guarantee for a total amount **of EUR 454,615 thousand** and UAH 1,805.11 million.

The decision of the Committee on the compatibility of State aid for competition (see Annex 1)

The Committee made **74 decisions** on the compatibility of State aid for competition. Separate decisions contain conclusions on the compatibility of the State aid provider makes changes to the terms of its provision, or if obligations are fulfilled, as well as on the compatibility for competition of State aid after 02.08.2022 if changes are made to the terms of its provision and obligations are fulfilled.

The decision of the Committee on the incompatibility of State aid for competition (see Annex 2)

The Committee adopted **19 decisions** on the incompatibility of State aid for competition, which concerned **performing the functions of the customer for the construction, reconstruction and repair of social and industrial infrastructure facilities, tax exemption by municipal enterprises, institutions and organizations and others. The decisions concerned the amount of UAH 238.1 million.**

At the same time, it should be noted that most decisions on the incompatibility of State aid for competition do not define the amount of illegal State aid, which is recognized as incompatible for competition and which should be returned to the relevant budget, due to the lack of a clear transparent calculation (or at least a methodology for such calculation), in what amount State aid should be provided.

The Committee decides on cases of State aid solely based on the information that it receives from grantors, recipients and third parties (if any). The Committee does not determine the amount of State aid that is incompatible for competition.

Compensation to the income of the general fund of the relevant budget is subject to the amount of illegal State aid actually used, which was recognized as incompatible for competition in accordance with the decision of the Committee.

In 2020, after a long trial, the budget of the Vinnytsia City United territorial community returned in full the actually used illegal State aid in the amount of UAH 40,187,800, which was recognized as incompatible for competition in accordance with the decision of the Committee of 20.11.2018 No. 652-p¹³.

This decision of the Committee was recognized as lawful by courts of all instances.

On March 31, 2020, in case No. 640/65/19, for the first time in the history of law enforcement of legislation on State aid in Ukraine, the Supreme Court decided to

<u>State aid in the form of financial support</u> – subsidies to cover losses from the provision of public passenger road transport services, including losses from free transportation of passengers by municipal vehicles on the days of national, citywide, new year and other holidays and events, for the period from 01.01.2018 to 31.12.2023 in the amount of UAH 407,772.2 thousand.

Justification of the Committee's decision:

ME "Vinnytsia transport company" was determined as a carrier without competition, the mandatory conduct of which is directly provided for by the law of Ukraine "On-road transport", so this enterprise is not a proper recipient of State aid;

ME "Vinnytsia transport company" competes with other carriers that carry out bus transportation of passengers in Vinnytsia;

the selectivity of providing support specifically for ME "Vinnytsia transport company" sets advantages for it and leads to a distortion of competition in the market of passenger transportation services; since the company received State aid before the Committee's decision was made – it is illegal.

dismiss the cassation appeal of the Department of energy, transport and communications of the Vinnytsia City Council, and leave the decision of the court of the first instance, which refused to satisfy the administrative claim, unchanged.

In August 2020, the Department of energy, transport and communications of the Vinnytsia City Council provided the Committee with copies of relevant bank statements confirming the fact of returning illegal State aid.

The Committee's decision to recognize support for undertakings as not a State aid

The Committee adopted **157 decisions**, which in the resulting part contain a conclusion on recognizing the support of undertakings as such, which is not State aid. The decisions concerned the amount of state support in the amount of **UAH 20,831.59 million.** In 2020, the share of relevant decisions from the total number of decisions taken on the merits was 73%, in 2019, such decisions were 83% of the total number, in 2018 - 94%.

1.3. Function of the Committee as an authorized body for monitoring State aid

The law assigns the Committee the function of monitoring State aid. Paragraph 5 of the first part of article 1 of the Law provides that monitoring of State aid is the collection and analysis of information on State aid in order to monitor compliance with the requirements of this Law and the decisions of the authorized body on State aid defined by this Law, as well as the preparation and submission of reports on State aid.

In terms of performing the function of monitoring State aid, the Committee analyzes draft regulatory legal acts regarding the presence of norms on State aid in them.

Thus, in 2020, the Committee analyzed and:

> conclusions were given to 193 draft Laws and Statutory Instruments (LSI) that have been received for approval from ministries and other central executive authorities, including:

agreed without comments – 124 LSI; agreed with the comments – 63 LSI; agreed after taking into account the comments provided – 6 LSI;

> comments were made on 55 LSI included by the Cabinet of Ministers of Ukraine in the agenda of meetings of the Government and Government Committees.

According to section 8 "Monitoring of State aid" of the Law, the Committee maintains a register of State aid, which is posted on the official website of the Committee under the heading "Portal of State aid". 14

This section also contains information about decisions taken by the Committee in the field of State aid and in relation to cases of State aid. During 2020, the Department of monitoring and control of State aid provided technical support for the State aid portal and filling in information by category:

- Register of State aid;
- Decision on State aid;
- State aid cases.

The Register information and analytical system include the function of the State aid register and the function of electronic document flow between State aid grantors and the Committee.

When monitoring State aid to undertakings, the Committee uses both information created in the Committee and information received from external sources.

In particular, in order to obtain indicators of State aid, the Committee summarizes information from State aid grantors about the current State aid, its purpose, forms, sources, recipients and their shares in the total amount of State aid provided during the last financial year under the relevant scheme, and information that no State aid was provided during the reporting year. According to the requirement of part three of Article 16 of the Law, all State aid grantors are required to submit relevant information to the Committee for the reporting year before April 1 of the following year for the reporting period. The procedure, forms and requirements for submitting information on current State aid to undertakings to the Committee were approved by the Committee's Order No. 43-pπ of 28.12.2015 (as amended by the Committee's Order No. 15-pπ of 19.07.2018).

However, despite the constant educational work of the Committee, which is carried out, in particular, by conducting training, seminars and webinars for representatives of various levels of government bodies, as well as sending reminder letters about the need to provide information to the Committee under the requirements of the law and the Committee's order of 28.12.2015 No. 43-pπ, there is a possibility of incomplete provision of information about current State aid by grantors.

When monitoring the submission of State aid notifications by grantors to the Committee, it was revealed that, as in previous years, the statistics on the submission of notifications by central executive authorities are very low. Of the total number of

notifications on State aid to undertakings received by the Committee during 2020, notifications from central executive authorities amounted to less than 10 % (in 2019 – 13 %).

In other words, the central executive authorities, which are the most significant grantors of State aid, do not fully fulfil their duty to submit notifications of State aid to undertakings.

In addition, even in the case of sending relevant notifications, as a rule, this is done after the adoption of a regulatory legal act, when it is too late to make any changes to it so that the State aid provided is compatible. Although, as noted above, the legislation stipulates that State aid grantors must submit to the Committee a notice of new State aid at least 105 calendar days before the planned date of entry into force of the relevant regulatory legal act or decision of the grantor allowing undertakings to receive new State aid.

Consequently, the process of notification of State aid, which is planned to be provided to undertakings, still requires significant improvement and control by the central executive authorities.

2. State aid for 2020

State aid should be a lever for developing strategies for the development of various sectors of the economy and ensure the achievement of goals by effectively spending public funds, mainly through State aid schemes. The practice of EU Member States shows that the development of State aid schemes will help reduce the number of cases of individual State aid that require assessment and approval of their compliance. Generally, government aid schemes make it much easier to provide aid at both the central and regional/local levels. Such government aid schemes would also increase the degree of legal certainty for beneficiaries, the general awareness of the business community about access to public finances, and the corresponding equal conditions in the markets.

2.1. General indicators of State aid

Some of the decisions taken by the Committee contain several conclusions:

- **157** decisions contain conclusions on the recognition of support for undertakings as such, which is not State aid;
- 74 the decisions contain conclusions on the compatibility of State aid for competition and concerned the amount over UAH 5 billion;
- 19 decisions contain conclusions on the recognition of State aid as incompatible for competition and concerned the amount over UAH 238 million.

The amount of State aid provided in 2020 in Ukraine, according to Central and local executive authorities and local self-government bodies, was **UAH 10,500.27**

<u>million</u>, with the average exchange rate of the National Bank of Ukraine for 2020 (1 euro = 30.79 UAH^{15}) – <u>EUR 341.03 million</u>. Also, according to the information provided by State aid grantors, the amount of de minimis State aid provided in 2020 was UAH 319.26 million. ¹⁶

So, the total amount of State aid, taking into account de minimis State aid, was **UAH 10,819. 53 million** in 2020.

Ukraine'S GDP (in actual prices)¹⁷ in 2020, amounted to **UAH 4,194. 10 billion**, 18 or **136.22 billion euros**.

State aid in 2020, according to data received from grantors, can be estimated at **0.26 %** of Ukraine's GDP.

The number of employed people aged 15-70 years in Ukraine in 2020 amounted to **15,915.3 thousand people**¹⁹.

State aid for each employed person aged 15-70 years in 2020, according to the data provided by the grantors, can be estimated at the level of <u>679.83 UAH/person</u>, or <u>EUR 22.08/person</u>.

The average annual population of Ukraine for 2020 is 41,575,748 people²⁰.

State aid for each citizen of Ukraine in 2020, according to the data provided, can be estimated at the level of **260.24 UAH/person**, or **EUR 8.45/person**.

2.2. Indicators of State aid by type of aid (based on information provided by grantors)

Information from State aid grantors on State aid provided in 2020 by type of aid is shown in figure 9.

Individual State aid²¹ – public aid event conducted outside public aid schemes, as well as individual measures of State aid under the public aid scheme, but subject to notification in accordance with the terms of such scheme and this Law.

State aid scheme²² – a normative legal act or a set of acts based on which certain categories of undertakings are provided with State aid for a certain or indefinite period in a certain or indefinite amount.

In 2020, the volume of support under State aid schemes exceeded the volume of aid provided as individual State aid and amounted to 64% of the total amount of State aid provided.

At the same time, it should be noted that there is a tendency for State aid grantors to neglect the development of State aid schemes and, in particular, the obligation to report various support measures, which can lead to a situation where State aid is not covered by pre-existing (ex-ante) controls.




Figure 10. Amount of State aid by forms of aid (according to information provided by grantors) in the structure of State aid in 2020

The most common form of State aid in 2020 is a subsidy, which, according to information provided by grantors, was 14%. Compensation for losses to undertakings amounted to 8%, fiscal measures -3%, subsidies -2%, guarantees -2%, an increase in the state share in the authorized capital of undertakings - less than 1%. Other forms of State aid -49%.

2.4. Indicators of State aid by type of economic activity (based on information provided by grantors)

The largest amount of State aid in 2020 was provided for the extraction of hard and brown coal (50%), the operation of land and pipeline transport (27%), activities in the field of creativity, art and entertainment (5%), sports (2%), air transport (2%), maintenance of homes and territories (2%). State aid to other types of economic activity did not exceed 1%.

The full list of State aid provided by the type of economic activity in 2020 is given in Annex 3 to the report.

2.5. Indicators of State aid by the source of funding (based on information provided by grantors)




Figure 11. Amount of State aid by sources of financing (according to information provided by grantors) in the structure of State aid in 2020, mln UAH

According to the information provided by State aid grantors, State aid in 2020 at the expense of local budgets amounted to 45% (including: city budgets -42%), the state budget -54%.




Figure 12. Amount of State aid by the form of ownership (according to information provided by grantors) in the structure of State aid in 2019, mln UAH

3. Indicators of de minimis State aid

De minimis²³ State aid is State aid to one undertaking, the total amount of which, regardless of its form and sources, does not exceed for any three-year period the amount equivalent to EUR 200 thousand, determined at the official exchange rate established by the National Bank of Ukraine, effective on the last day of the financial year.

According to Article 9 of the Law, notification of de minimis State aid is not submitted if it does not directly relate to the support of export operations or the predominant use of domestic products in comparison with imported products.

The legislation does not provide for the decision of the Committee to recognize the relevant State aid as de minimis. The State aid grantor independently decides whether such State aid is de minimis.

However, information on de minimis State aid is provided by the provider of such aid to the Committee within the framework of the authorized body monitoring State aid in compliance with the requirements of the procedure, forms and requirements for submitting to the Committee information on current State aid to undertakings, approved by the Order of the Committee of $28.12.2015 \text{ N}_{\text{\tiny 2}} 43$ -pπ, registered with the Ministry of Justice of Ukraine $26.01.2016 \text{ N}_{\text{\tiny 2}} 140/28270$ (as amended by the Order of the Committee of $19.07.2018 \text{ N}_{\text{\tiny 2}} 15$ -pπ, registered with the Ministry of Justice of Ukraine 16.08.2018 for No. 942/32394).

State aid providers provided information on the de minimis State aid provided in 2020 in the amount of **319 260,23 thousand UAH.**




Figure 13. Insignificant State aid provided in 2020 by region (according to the information provided by the providers), mln UAH

4. Indicators of state support for municipal and state-owned enterprises

In 2020, the Committee adopted 191 decisions concerning financial support for municipal and state-owned enterprises, 25 decisions were made to support specific private enterprises, undertakings regardless of the form of ownership, etc. (see fig. 14).




Figure 15. Structure of the Committee's decisions on municipal and stateowned enterprises in 2020 by classifiers of economic activities

Most of the 191 decisions of the Committee concerning the support of municipal and state-owned enterprises, namely 65 decisions, according to the classifiers of economic activities (CEA section) related to activities in the field of administrative and support services (improvement, maintenance of parks, street and road network, outdoor lighting networks, etc.); other decisions: regarding the development of transport-35 decisions; construction – 21 decisions; processing industry – 18 decisions; art and sports – 14 decisions; maintenance and reconstruction of water supply, sanitation, heating networks – 9 decisions; healthcare – 8 decisions; other – 20 decisions (see fig. 15).

The decisions of the Committee, as the authorized body for State aid to undertakings, concerned the support/State aid of municipal and state-owned enterprises for general use

the amount of UAH 27,557.49 million, including:

- ✓ non-State aid UAH 20,643. 5 million;
- ✓ compatible State aid UAH 4,853. 39 million;
- ✓ incompatible State aid -232,5 million UAH;
- ✓ state support specified in decisions on the implementation of the functions of the customer, for which the corresponding amounts of compatible/incompatible State aid for a competition cannot be established at the time of making such decisions, UAH 1,828.11 million.

5. Legislative and rule-making activities

The association agreement stipulates that in Ukraine the system of regulating State aid to undertakings should correspond to a similar system in the EU. Ukraine has an obligation to coordinate competition legislation and its application practices with the EU acquis²⁴ in the sphere of State aid (Article 256 of the Association Agreement).

Currently, under Article 264 of the association agreement, the parties have agreed that they will apply articles 262, 263(3) or 264(4) of this Agreement (the article specifically concerning State aid) using as a source of interpretation the criteria arising from the application of Articles 106, 107 and 93 of the Treaty on the functioning of the European Union, in particular the relevant case-law of the Court of Justice of the European Union, as well as the relevant secondary legislation, framework provisions, guidelines and other applicable administrative acts of the Union.

At the same time following Article 267 of the Association Agreement, the transition period for preparing national legislation for the requirements ends in December 2022 legal system European Union.

Therefore, the Committee is constantly taking measures to improve the necessary regulatory framework in the field of State aid.

- ❖ In 2020, the following criteria for assessing the compatibility of State aid developed by the Committee were submitted to the Cabinet of Ministers of **Ukraine:**
- > Criteria for assessing the compatibility of State aid to undertakings in the coal industry.²⁵

The criteria for assessing the compatibility of State aid to undertakings in the coal industry were developed to create legal and organizational mechanisms for implementing the provisions of the law of Ukraine "On State aid to undertakings" in terms of assessing the admissibility of State aid in the coal industry.

The implementation of state control over the compatibility of State aid provides for the emergence of relations between the authorized body, grantors and recipients of State aid at various stages of providing state support, in particular, at the stage of its planning.

According to the principles enshrined in the Treaty on the functioning of the European Union, the Association Agreement, the law of Ukraine "On State aid to undertakings", any State aid that distorts or threatens to distort economic competition, creating advantages for the production of certain types of goods or the implementation of certain types of economic activities, is prohibited (except for several exceptions provided for by law).

The introduction of criteria will protect the interests of society from distortion of competition and inefficient functioning of commodity markets due to unsatisfactory and uncontrolled provision of such State aid.

The resolution defines the criteria for assessing the compatibility of State aid provided to undertakings in the coal industry for:

- closure of coal mining enterprises or their separate divisions;
- covering exceptional expenses;
- ensuring access to coal reserves:
- measures for technical re-equipment and modernization of coal mining enterprises;
 - covering current expenses.

The regulatory act is designed to introduce legal regulation of relations between the Committee (as the authorized body for State aid), State aid grantors and its recipients when assessing the compatibility of State aid to undertakings in the coal industry.

> Criteria for assessing the compatibility of State aid to undertakings to overcome the consequences caused by the coronavirus disease COVID-19²⁶

The purpose of the government decree "On approval of criteria for assessing the compatibility of State aid to undertakings to overcome the consequences caused by the coronavirus disease COVID-19" is to establish legal support for the assessment of measures to support undertakings aimed at overcoming the negative economic consequences associated with the coronavirus disease COVID-19.

The criteria were developed for the implementation of the state program to stimulate the economy to overcome the negative consequences caused by restrictive

measures to prevent the occurrence and spread of acute respiratory disease COVID-19 caused by the SARS-CoV-2 coronavirus for 2020-2022, approved by resolution of the Cabinet of Ministers of Ukraine No. 534 of 27.05.2020.

Now the spread of the coronavirus disease COVID-19 is an emergency not only in the healthcare sector but also in any area of the economy that provides society with goods and services. Various disease containment measures are taken by the state, such as social distancing measures, travel restrictions, and other quarantine measures, which can negatively affect both demand and supply and, as a result, restrict and prevent undertakings from carrying out economic activities in full. Often, small and medium-sized businesses experience certain difficulties due to a possible lack of liquidity or a sudden lack of material resources. The state's response in the form of support for certain undertakings is crucial to mitigate the negative impact on the economy associated with the coronavirus disease COVID-19. At the same time, such support can have a negative impact and distort economic competition, so the approval of criteria by the government will allow evaluating such measures for compatibility with competition and the proper functioning of the market for goods and services.

This Regulatory Act defines the range of undertakings to which the criteria are applied, the purpose for which State aid is provided, and its forms.

The criteria define several types of State aid and the conditions under which such State aid is compatible. In particular:

- State aid of up to 400 thousand euros for all undertakings affected by quarantine, which prevents them from carrying out economic activities;
- investment State aid for the production of relevant goods related to the prevention, occurrence, spread, treatment and prevention of COVID-19;
 - State aid in the form of new guarantees for individual loans;
 - State aid in the form of compensation of interest rates on loans;
- State aid in the form of deferred payment of taxes and/or social security contributions;
 - State aid for partial unemployment for the quarantine period.

Criteria for assessing the compatibility of State aid to undertakings have been developed for temporary measures aimed at supporting the economy in the context of the coronavirus disease COVID-19. These criteria are prepared based on the norms of secondary EU legislation²⁷, as well as considering the specifics of national legislation.

> Criteria for assessing the compatibility of State aid to undertakings for Environmental Protection²⁸

The purpose of adopting the act is the creation of legal and organizational mechanisms for implementing the provisions of the law of Ukraine "On State aid to undertakings" regarding the assessment of the compatibility of State aid for environmental protection for competition.

Now there is a need to determine the criteria for assessing the compatibility of State aid to undertakings for Environmental Protection at the bylaw level (by an act of the Cabinet of Ministers of Ukraine), which will fix legal and organizational mechanisms for implementing the provisions of the law of Ukraine "On State aid to undertakings" regarding the assessment of the compatibility of State aid for environmental protection for competition.

The problem cannot be solved with the help of existing regulatory acts, since none of them regulates the definition of criteria for assessing the compatibility of State aid to undertakings for Environmental Protection.

Criteria for compatibility the admissibility of State aid for Environmental Protection provided to undertakings for the purposes provided for in part one of Article 6 of the law of Ukraine "on State aid to undertakings", will be applied by the authorized body for State aid to assess the compatibility of current and new State aid for Environmental Protection and make a decision on recognizing such State aid as compatible in accordance with Part Four of Article 6 of the law of Ukraine "On State aid to undertakings".

Defining criteria for assessing the compatibility of State aid to economic entities for environmental protection protects the interests of society from distortions of competition and inefficient functioning of commodity markets due to inefficient and uncontrolled provision of such State aid.

The Regulatory Act is designed to introduce legal regulation of relations between the Antimonopoly Committee of Ukraine (as the Authorized body for State aid), grantors of State aid and its recipients in determining the compatibility of State aid to economic entities for environmental protection.

The draft resolution proposes to define the conditions and criteria for determining the compatibility of State aid for Environmental Protection.

The criteria will determine:

purpose and forms of State aid;

categories of recipients of State aid;

the maximum amount of State aid that can be provided;

conditions and method for calculating the total amount of State aid;

expenses that can be reimbursed to recipients of State aid.

The adoption of the act will facilitate Ukraine's fulfilment of the obligations assumed following the first part of article 267 of the Association Agreement between Ukraine and the EU regarding the adoption of national legislation on State aid.

❖ In 2020, a new version of the Law of Ukraine "On State aid to undertakings" was developed

The new version of the Law of Ukraine "On State aid to undertakings" developed by the Committee was posted on the official website of the Committee, actively discussed and finalized with representatives of the relevant executive authorities, the business community, international partners, and was reflected in the draft law "On amendments to the Law of Ukraine "on State aid to undertakings" and other legislative acts of Ukraine on improving the control and monitoring of State aid to undertakings" (registration No. 5648 of 10.06.2021). ²⁹ submitted to the Verkhovna Rada of Ukraine by people's Deputies of Ukraine R. Pidlasa, D. Arahamia and others.

The purpose of the draft law is to bring national legislation to the rules of control and monitoring of State aid, which are enshrined in the Association Agreement and the EU acquis, as well as to improve the established legal regulation to effectively function the system of control and monitoring of State aid.

In particular, the draft law in the definition of "State aid to undertakings" provides for an important component – the effect on international trade between Ukraine and the EU countries, which is an integral feature for recognizing state support as State aid, according to the provisions of the Association Agreement and the relevant secondary EU legislation.

The draft law also proposes to establish a new definition of "undertaking" for the sphere of State aid and provide a definition of "economic activity" that will be covered by the law, which will also have a positive impact on the work of the Committee, its institutional capacity and narrow the number of cases of recognition of state support as State aid.

In addition, the draft law proposes to provide definitions: "advantage", "date of State aid granting", "date of receipt of State aid at the disposal". The draft law details the provisions on de minimis State aid, services of general economic interest, and forms of State aid, which will have a positive impact on the awareness of State aid grantors.

The proposed changes fill in the gaps existing in the current law. Thus, Article 3 of the current law provides that the list of services of general economic interest is

established by the Cabinet of Ministers of Ukraine, but this approach conceptually does not comply with the norms of EU legislation, according to which compensation for the provision of services is assessed either as non-State aid or as compatible State aid.

The provision that the authorized body, in addition to national legislation, is guided by the provisions of international treaties, framework provisions, guidelines and other EU acts when making a decision, ensures compliance with the obligations established by the Association Agreement and also allows for thorough and effective consideration of notifications and cases of State aid.

The draft law proposes to establish an important tool – the statute of limitations for the return of State aid, which does not exist in the current law.

In addition, for effective and rapid consideration of notifications and cases of State aid, the draft law proposes the distribution of powers between the authorized body and the bodies of the authorized body (administrative board (collegiums), State Commissioners of the Committee), improves the procedure for reviewing notifications, cases, reviewing decisions, considering applications for illegal State aid, and also sets a fine for undertakings in case of failure to submit information to the Committee in the amount of one percent of income from the sale of products for the last reporting year as part of the consideration of the case. This provision is borrowed from the European Commission's Secondary Legislation Act 2015/1589.

So, the proposed changes will have a positive impact on the functioning of the system of control and monitoring of State aid in Ukraine, as well as allow focusing the country's attention on larger and more complex cases of State aid that affect international trade between Ukraine and the EU, which is the main goal of the system of control over State aid.

6. Raising awareness in the field of State aid

The development of the national system of State aid control in Ukraine is at an initial stage. To further develop an effective system of State aid, one of the priority areas of the Committee's work, as in previous years, remains the dissemination of knowledge about State aid.

During 2020:

- ✓ more than 7180 consultations were held with State aid grantors;
- \checkmark 13 presentations on State aid were made at conferences, seminars and meetings;

In 2020, the Committee provided 106 explanations on the application of legislation in the field of State aid based on written requests from state support grantors and recipients.




Figure 16. Number of clarifications by year

The number of such clarifications decreases annually, due to the constant holding of relevant consultations by the Committee's specialists. The official web portal of the Committee publishes the most common questions and answers regarding State aid, which are currently relevant³⁰.

During 2020, the Committee continued to cooperate with the EU Technical assistance Project "Support of the Antimonopoly Committee of Ukraine for Enforcing State aid rules" (hereinafter referred to as the SESAR project).

In 2020, specialists of the State aid Monitoring and Control Department of the Committee continuously participated in training courses organized by the SESAR Project to deepen knowledge about State aid to ensure better application of EU State aid rules and develop new skills in evaluating notifications, conducting investigations, preparing decisions, etc.

To implement EU Best Practices in Ukraine, representatives of the Committee took part in a study visit to Slovakia and Hungary in February 2020, during which they got acquainted with the methodology and procedures for considering issues related to State aid to undertakings, as well as the practical implementation and use of criteria for the compatibility of State aid in these countries.

The Committee's specialists took part in seminars on the practical aspects of the system of law enforcement and competition advocacy in the EU countries, organized by the SESAR project in the cities of Zaporizhzhia, Mariupol and Lviv to improve the skills of representatives of the territorial offices of the Committee and the level of awareness of State aid grantors at the local level on the application of legislation in the field of State aid.

The two-day courses of seminars held in these cities covered topics that are essential for understanding by all parties involved in the application of State aid rules defined by law and relevant bylaws. The main goal of the course is to provide participants with a basic knowledge of the concept of State aid, the categories of State aid (objectives) that may be compatible, the main forms and tools of State aid, specific

sectoral rules of aid, and legislative procedures regarding the notification requirement. Speakers and trainers of such seminars were SESAR project experts and Committee specialists.

During the seminars, specialists of the Department of monitoring and control of State aid of the Committee presented topics on the specifics of monitoring and controlling State aid in Ukraine, and EU experts – EU rules and experience on similar approaches in applying State aid rules in Member States.

Starting from April 2020, the SESAR Project started organizing specialized online training for the Committee's specialists with experts of this Project. This format proved to be quite effective for training and communication during quarantine measures.

More than 20 webinars were held, including with the involvement of representatives of the territorial branches of the Committee and interested authorities, in particular, on the following topics:

"The concept of State aid";

"Covid - 19 and State aid rules";

"State aid for professional training of employees";

"State aid for restoration and restructuring";

"Return of illegal State aid";

"Establishing the intensity of State aid";

"State aid for scientific research, technological development and innovation";

"Methodology for calculating the aid element";

"Applicability of general economic interest services in the transport sector";

"Changes in the Law on State aid. Criteria for the compatibility of State aid for culture";

"Changes in the Law on State aid. Criteria for the compatibility of State aid for sports";

"Calculating the aid element. Rural branch of Ukrposhta";

"Development of guidelines for State aid accounting and Account Allocation".

In Autumn 2020, agreements were reached to extend the SESAR Project for 2 years – until December 2022, which will contribute to the further development of the Institute of State aid in Ukraine and bring national competition legislation closer to EU standards under the Association Agreement.

Conclusions and areas requiring attention

The annual report for 2020 is compiled based on information on State aid to undertakings received by the Committee from Central and local executive authorities, local self-government bodies that provide State aid.

As practice shows, despite the constant educational work of the Committee, which is carried out, in particular, by conducting training, seminars and Webinars for representatives of various levels of Government, Local Self-Government bodies, as well as sending reminder letters about the need to provide information to the Committee following the requirements of the law and orders of the Committee from 04.03.2016 No. 2-pπ and 28.12.2015 No. 43-pπ, there is a possibility of incomplete provision by financial support grantors of information about current and new State aid, reporting on its volumes, and incomplete reporting on the amount of de minimis State aid.

Accordingly, there is a need to raise awareness of State aid grantors to improve their compliance with the norms of legislation in the field of State aid.

Conclusions

1. Ukraine has established and operates a system for monitoring State aid and monitoring the compatibility of State aid for competition.

In the reporting year, the Committee's quantitative performance indicators are lower compared to 2018 and 2019.

On the one hand, this situation is related to quarantine conditions caused by the SARS-CoV-2 coronavirus, which could lead to a decrease in the number of reports of new State aid.

On the other hand, the number of reports on new State aid, based on the results of consideration of which the Committee recognizes state support to undertakings as not being State aid following the Law, has decreased. There were 157 such decisions in 2020, 269 in 2019, and 174 in 2018, which in relative terms of the total number of decisions taken in the corresponding years is 73% in 2020, 83% in 2019, and 94.1% in 2018.

In the reporting year, compared to 2019, the number of written individual requests for clarification on the application of legislation in the field of State aid halved (compared to 2018 – three times), taking into account the constant conduct of relevant consultations by the Committee's specialists and the most common questions and answers on State aid posted on the Committee's website.

This trend is positive, as it indicates a gradual increase in awareness of State aid grantors as a result of the Committee's outreach work, and also allows the Committee to focus on more complex and significant issues. In particular, such as identifying illegal State aid and recognizing such State aid as incompatible for competition. If in 2018 there were only 2 out of 185 such decisions, in 2019 – 13 out of 324, then in 2020 – 19 out of 216.

- 2. Currently, the statistics of notification submission by central executive authorities are quite low, as in previous years. Of the total number of notifications on State aid to undertakings received by the Committee during 2020, notifications from central executive authorities amounted to less than 10 % (in 2019 13 %). In addition, even in the case of sending relevant notifications, such a notification is sent, as a rule, after the adoption of a normative legal act, when it is too late to make any changes to such an act so that the State aid provided is compatible. In other words, the central executive authorities, which are the most significant grantors of State aid, do not fully fulfil their duty to submit notifications of State aid to undertakings. Consequently, the process of notification of State aid, which is planned to be provided to undertakings, requires significant improvement and control.
- 3. In 2020, the volume of aid under State aid schemes exceeded the volume of aid provided as individual State aid and amounted to 64% of the total amount of State aid provided. At the same time, it should be noted that there is still a tendency for State aid grantors to neglect the development of State aid schemes.

But, as the practice of EU Member States shows, the development of State aid schemes will help reduce the number of cases of unplanned and non-transparent individual State aid that require assessment and approval of their compliance. Generally, government aid schemes make it much easier to provide aid at both the central and regional/local levels. The development of State aid schemes, instead of individual measures, will increase the investment attractiveness of the country as a whole and its regions, provide legal certainty for recipients, equal and stable conditions of activity in the relevant markets, improve planning and transparency of state and local budget expenditures, as well as the publicity of such information.

- 4. When forming the annual budget of Ukraine, it is necessary for State aid grantors to comply with the requirements of part four of article 35 of the Budget code of Ukraine. At the same time, many State aid grantors do not comply with this requirement. Accordingly, that direction also required the attention of the Committee.
- 5. Most of the Committee's decisions in 2020, as in previous years, concerning support for municipal and state-owned enterprises 88% of the total number of decisions on providing State aid. In 2019, the share of such decisions was about 84%.

It should be noted that the regulatory framework in the field of State aid, which operates in Ukraine, is the same for undertakings of all forms of ownership.

Interested parties have the opportunity to apply to the Committee with an application regarding illegal State aid and/or improper use of State aid. Special requirements for the content and procedure for processing such an application are

defined in the procedure for considering cases on State aid to undertakings, approved by Order No. 8-pπ of the Antimonopoly Committee of Ukraine dated 12.04.2016.

6. To coordinate national legislation in the field of State aid with the EU acquis, it is necessary to further improve the regulatory framework and identify measures for State aid grantors that would encourage them to meet the requirements of legislation in the field of State aid.

Now it is extremely important to focus on improving the existing gaps in the practical application of European norms and rules for providing, monitoring and controlling State aid in Ukraine.

In 2020, specialists of the State aid Monitoring and Control Department of the Committee continuously participated in training courses organized by the SESAR project to deepen knowledge about State aid to ensure better application of EU State aid rules and develop new skills in evaluating notifications, conducting investigations, preparing decisions, etc.

At the same time, the Department of monitoring and control of State aid of the Committee carries out significant work in terms of advocacy of the system of monitoring and control of State aid, so that in general the situation of awareness of authorities and recipients in the field of State aid improves. Since this work is long-term and comprehensive, the Committee continues to raise the general level of awareness of grantors and society about the institution of State aid to undertakings.

Taking into account the analysis carried out and the practical work of the Committee during 2020, we can distinguish the following **priority areas requiring** attention

in 2021 on the way to becoming an effective system of State aid:

- making decisions following the law of Ukraine "On State aid to undertakings" based on the results of consideration of notifications and cases on new State aid;
 - improving the regulatory framework for State aid;
- ensuring that the European Commission is informed about the provision of State aid in Ukraine following the requirements of the Association Agreement;
- providing explanations on the application of legislation in the field of State aid;
- taking measures to intensify the submission of State aid notifications and relevant reports by central executive authorities;
- advocacy of the State aid system in terms of developing State aid schemes by grantors;

- conducting various events to continuously raise awareness of State aid grantors and recipients.
